Course Description:

Traditionally, Trial Advocacy is a free-standing three-credit course while mock trial competitions are a one-to- two credit supplemental law school activity, done in addition to a student's full-course load. This course is designed to incorporate the best aspects of traditional trial advocacy classes and mock trial competitions into a single three-credit class. To achieve this end, the proposed course has two "twists." The first "twist" is having the students initially learn and practice trial advocacy skills in class. Then, the students will apply and practice theses skills through a series of "scrimmages" and final trials against students from another law school, Syracuse University. The second "twist" is the case files specifically developed for this course. The case files (other than possibly the final trial case file) will be shorter (no more than 15 pages, including pleadings) in contrast to the more complex case files running 70 or more pages typically used in a one-off mock trial competition.

In terms of course structure, the first two weeks of the class would involve purely classroom instruction and practice, with the instructor providing an Prerequisite Requirements for this Course: First year courses. Completion of Evidence is preferred though not required.
